A regular meeting of the Redford Union Board of Education was held March 9, 2009, at the John C. Raeside Administration Building, 18499 Beech Daly, Redford Township, Michigan, 48240. President Gubachy called the meeting to order at 7:33 p.m.

Superintendent's Remarks

## Superintendent Rhodes spoke to:

- Acknowledged a former Redford Union School Board member of 25 years, Gordon Brocklehurst, who passed away at the age of 93 on March 4th. Mr. Brocklehurst is recognized for his dedication and devotion to Redford Union Schools at this time.
- The stimulus money and the email received that recommended Superintendents are cautious. Current plans for the stimulus money for schools would come in through Title I for at-risk students or IDEA, Individuals with disabilities for special education programs. The stimulus money must be spent within two years. There has been no notification of when the money will be available to districts at this time. Redford Union Schools has submitted building repair and improvement proposals to the Michigan Federal Economic Recovery group and the District's request are currently listed and awaiting approval. There is a need for 42 million to do all the repairs and improvements that were identified by the Facilities Advisory Committee. There is a Bond Proposal for 12.53 million on May 5<sup>th</sup> and indications are if there is stimulus money coming for building maintenance it would be approximately 1.3 million.
- Student count will be completed this Wednesday, March 11<sup>th</sup>. We are hopeful that the loss of students will not be significant. A solid count should be available by March 11<sup>th</sup>.
- We continue to struggle to come to a resolution with the RUEA on a contract. Health care and prescription drug coverage is a huge part of that struggle. With the cooperation of the RUEA and District negotiation team all insurances have been bid out. The bid was written cooperatively at the table for health, prescription, vision, dental, long-term and short-term disability coverage. The bid was published on March 1<sup>st</sup>, 5<sup>th</sup>, and 8<sup>th</sup> and responses are due at the Board office on March 26<sup>th</sup>. There will be an opening and evaluation of the bids and hopefully this will open new discussion at the bargaining table.

Caloia stated that Brett Steele, Athletic Director, and Donna Rhode, Superintendent, contracts should be kept separate. Wujcik questioned the amount that Administrators pay toward health care coverage. Caloia questioned the responsibilities of the Athletic Director. The Superintendent commented on the additional responsibilities that have been added to the Athletic Director over the course of the 2008-2009 school year. Caloia stated that she did not believe the Superintendent's contract should be discussed with the Superintendent present. The Superintendent explained that the Athletic Director is part of the Administrators bargaining group and the Board would have to address the Redford Union Administrative Association to address Brett Steele's contract separately.

<u>MOVED</u> by Isabell, seconded by Caloia to amend the previous motion to approve the contract extensions through 2011 for the Administrators/Supervisors/Exempt Employees with the exception for Brett Steele and Donna Rhodes. Ayes: All. Motion: Carried.

Brenner invited Michael Dennis, from the Redford Township Building Commission to speak to the Board regarding plans by the Downtown District. Four years ago Roosevelt was added into that Downtown District. Dennis spoke about all the options available for the Downtown District from movie productions to senior living. It is the goal to make a more walk able downtown. Dennis believes the real estate market is going to come back in the Redford area and spoke about the Stabilizing Neighborhood Act Plan. Brenner asked Dennis to comment on the Roosevelt lease. Dennis supported the lease of Roosevelt to Alano. Board discussion was had on the pros and cons of maintaining Roosevelt with the option of leasing and tearing it down. Members of the Facilities Advisory Committee also commented on the leasing of Roosevelt. After discussion a vote was called by Gubachy. Ayes: All. Motion: Carried.
