## SPECIAL MEETING MINUTES – BOARD OF EDUCATION REDFORD UNION SCHOOLS, DISTRICT NO. 1 May 24, 2010

Special Meeting 5/24/10 Call to Order

A special meeting of the Redford Union Board of Education was held May 24, 2010, at the John C. Raeside Administration Building, Redford Township, Michigan, 48240. President Isabell called the meeting to order at 7:45 p.m.

Adoption of Agenda

Karen Moffitt, Assistant Superintendent of Business Services, presented the proposed budget for 2010-2011. Moffitt reviewed the way schools are funded. Moffitt noted the decline of 1300 students over the last 5 years and the decline in revenue. Moffitt estimated that the district "would be close to breaking even or hopefully end up with a little bit of fund balance for the current year. "Moffitt reviewed expenditures of 2010-2011 and informed the Board that it is required by law to adopt a balanced budget. Salary and benefits make up 84% of the total budget. Moffitt stated, "as you can see, when you have to cut 2.4 million dollars you are looking at people: salary, benefits, or positions." Moffitt provided a list of proposed reductions after meeting and taking suggestions from board members, unions, staff members and the strategic planning committee members. All reductions would be to the general fund budget. Center programs are funded through Act 18 and the county.

Presentation 2010-2011 Proposed Budget

Board discussion included school of choice for K-1 students, closing of Pearson, moving alternative education to the high school and combining programs or buildings to fill Pearson. ADT program location and the Act 18 funding were discussed. Superintendent Stoneman added that variables will be retirements and student count.
