Section 31aa Funds – Adam Blaylock, Attorney, Miller Johnson

Attorney Blaylock explained the acceptance of Section 31 AA funds, which offer \$140 per student for school safety and mental health. The funds require districts to agree to a comprehensive investigation and waive privileges in case of a mass casualty event. He explained what a mass casualty event is broader than just

school shootings, including incidents resulting in significant injuries or requiring emergency services beyond normal resources. Attorney Blaylock primary goal tonight was to provide guidance to the superintendent on next steps regarding Section 31 AA funds. He mentioned recent changes in the litigation schedule, allowing districts to opt in and rescind their decision by December 30. He also explained the new requirement for districts to agree to a comprehensive investigation and waive privileges in case of a mass casualty event.

There were questions and answers.

The board discussed the financial implications of accepting or declining the funding, including the potential impact on staffing and security.

Attorney Blaylock reiterated the importance of being fully informed before making decisions and the need for a resolution directing the superintendent.

The Board decided they would vote on the current resolution instead of tabling the discussion and agreed to have a new resolution brought forward for consideration at the December 1, 2025 regular meeting.
